

DEED OF UNDERTAKING

KNOW ALL MEN BY THESE PRESENTS:

_____ a corporation/ association/
local government unit duly organized and existing under and by virtue of the
laws of the Republic -of the Philippines with principal office or place of business
at _____, Taguig City, represented herein by its
President, after being sworn in accordance with the law, hereby state:

1. We have identified and established within our premises a common space which can be utilized as a **Safe Zone**, as defined under Public Advisory No. 4 issued by the City Government of Taguig, through the Taguig Safe City Task Force, on 18 May 2020;
2. We are aware that the proposed **Safe Zone** is highly regulated by the City Government that is reserved for use by all residents, particularly senior citizens and children.
3. We are aware that the proposed **Safe Zone** shall only be allowed to open upon filing of the application for the issuance **Safe Zone Clearance**, submission of documentary requirements, and inspection by the Taguig Safe City Task Force (Task Force) or its duly authorized representatives;
4. During the inspection of the proposed **Safe Zone**, we shall conduct a walk-thru of the area, showing the measures taken and the protocols in place to ensure that social distancing and other minimum public health standards are complied with and strictly enforced within the proposed **Safe Zone** (i.e. provision of alcohol or sanitizer and regular disinfecting schedule);
5. We agree that once the designated **Safe Zone** is allowed to open, we shall appoint a **Safe Zone Administrator (“SZA”)**, to limit, regulate and monitor its use. For this purpose, we are appointing _____, as our SZA;
6. We agree that the approved designated **Safe Zone** shall operate under the guidelines set forth in said Public Advisory;
7. We are aware that any violation of said Public Advisory may result to revocation of the **Safe Zone Clearance** issued closure of our common space. Notwithstanding to penalty prescribed by Republic Act No. 11469, otherwise known as the “Bayanihan We Heal As One Act,” Republic Act No. 11332, otherwise known as the “Mandatory Reporting of Notifiable Diseases and Health Events of Public Health Concern Act” in relation to Presidential Proclamation No. 922, and other applicable laws and ordinances.
