RE: **Placement of Certain Areas under Granular Lockdown**

Based on the data of the City Epidemiology and Disease Surveillance Unit (CEDSU), using the latest data from the Systematic Mass Approach on Responsible Testing (SMART) program, the following list of areas attached herein as Annex "A" are identified as critical zones due to the high number of COVID-19 cases. Hence, **starting November 19, 2021 until December 2, 2021**, the following areas shall be **placed under Granular Lockdown**.

The Quarantine and Containment Management Team (QCMT) are reminded to implement the guidelines provided in Safe City Task Force Advisory No. 52.

Any person in violation of these guidelines shall be penalized in accordance with Republic Act No. 11332, otherwise known as the "*Mandatory Reporting of Notifiable Diseases and Health Events of Public Health Concern Act*" in relation to Presidential Proclamation No. 922, Taguig City Ordinance No. 24, Series of 2020, otherwise known as the "*New Normal Ordinance of Taguig City*" and other applicable laws and ordinances. This will be without prejudice to the filing of an administrative case if the violator is a government official or employee.
